Text of the motion to remove a member of the Executive Board must be delivered to each member of the SCCA two weeks prior to the meeting at which the motion will be made. Removal from office shall be effective immediately upon proper passage of the motion to remove the officer. The member of the board removed by such action shall be eligible to serve as a member of the Executive Board after a period of two years from the date of removal from office.
